## Introduction

## Information We Collect

### Personal Information

- **Account Information:** Email address, name, and password when you create an account
- **Profile Data:** Daily goals, preferences, and settings you configure
- **Task Data:** Tasks, deadlines, and progress information you create

### Usage Information

- **App Usage:** How you interact with the app, features used, and time spent
- **Device Information:** Device type, operating system, and app version
- **Performance Data:** App crashes, errors, and technical diagnostics

## How We Use Your Information

We use the collected information for the following purposes:

- Provide and maintain the Swipe it off service
- Personalize your experience and improve our app
- Send you important updates and notifications
- Analyze usage patterns to enhance functionality
- Provide customer support and respond to inquiries
- Ensure security and prevent fraud

## Data Storage and Security

We implement appropriate security measures to protect your personal information against unauthorized access, alteration, disclosure, or destruction.

**Your data is stored securely using industry-standard encryption and security practices.**

We use Supabase as our backend service provider, which maintains high security standards and compliance with data protection regulations.

## Data Sharing

We do not sell, trade, or rent your personal information to third parties. We may share your information only in the following circumstances:

- **Service Providers:** With trusted third-party services that help us operate our app (e.g., Supabase for data storage)
- **Legal Requirements:** When required by law or to protect our rights and safety
- **Business Transfers:** In connection with a merger, acquisition, or sale of assets

## Your Rights

You have the following rights regarding your personal information:
