

Terms of Service

Acceptance of Terms

By downloading, installing, or using the Swipe it off mobile application ("App"), you agree to be bound by these Terms of Service ("Terms"). If you do not agree to these Terms, please do not use our App.

These Terms apply to all users of the App, including without limitation users who are browsers, vendors, customers, merchants, and/or contributors of content.

Description of Service

Swipe it off is a productivity application designed to help users manage tasks, set daily goals, and improve their productivity through deadline-driven task management.

The App provides the following features:

- Task creation and management
- Swipe-based task commitment system
- Daily goal setting and tracking
- Focus mode for distraction-free work
- Progress tracking and statistics
- Deadline management and reminders

User Accounts
